Pursuant to the Public Limited Companies Act which prescribes that the Annual General Meeting of Shareholders shall appoint auditors and consider the remuneration of the auditors every year. In this regard, the Board of Directors has considered and approved to propose to the Annual General Meeting of Shareholders the appointment of the auditors and the determination of remuneration of auditors for the Year 2024 by appointing auditors from KPMG Phoomchai Audit Ltd. Regarding the remuneration of auditors for the Year 2024, the Board of Directors has approved to propose to the Annual General Meeting of Shareholders the determination of remuneration of auditors in an amount of THB 3,550,000, excluding other actual payable non-audit fee. The aforementioned audit fee increases because of the surge in transaction volume, by acquisition and entire business transfer from the group of SCG Logistics Management Co., Ltd.. As a result, additional time was necessary to effectively work the case. However, the total audit fee for the group of companies in 2024 decreases by 46,100 baht, equivalent to 0.42% compared to the previous year.

The aforementioned audit fee is inclusive of 3 quarterly review and the year-end audit of the Company's financial statements. In addition, the Board of Directors has proposed to authorize the management to consider and approve other remuneration of the auditors, other than the fees mentioned above, as appropriate.
