

Details of the Objectives (Amendment)

of

SCGJWD Logistics Public Company Limited

The objectives of the Company have 73 items.

- (1) To engage in the business of production, purchase, sale, exchange, hire of or by doing other things that cement Any other product manufactured with cement as part of the raw material. concrete products concrete tile All types of roof tiles ceramic tile Pottery, ceramics, other products made of concrete reinforced concrete reinforced concrete as well as any materials or equipment used or relating to construction, industry, as well as providing various services related to the aforementioned products
- (2) To engage in the business of producing, buying, selling, exchanging, or doing any other acts of materials used or related to the construction of concrete, reinforced concrete; Prestressed concrete such as cement, steel, brick, stone, gravel, sand and cement-based materials, etc.
- (3) To engage in the business of production, purchase, sale, exchange, hire of or by any other means of iron, steel, ductile iron, cast iron, alloy steel, copper, brass, aluminium, iron, various forms, metal products Ferro alloy products, scrap and scrap metal of all kinds, refractory bricks and other metals, in the form of minerals, ingots, cast in forms, sheets, lines, pieces or in other forms used or in connection with construction, industry and any other product containing iron or other metal as part of its raw materials.
- (4) To engage in the business of production, purchase, sale, exchange, hire of or do by any other means of timber, sawn timber, alternating plywood all kinds of plywood other wood products furniture all types of wood planks which is coated and or printed with various materials, including any other product made from it above or manufactured with wood as part of the raw material, or used or in connection with construction or industry
- (5) To engage in the business of production, purchase, sale, exchange, hire of or do by any other means of rubber, cotton, rayon, nylon, plastic pellets, synthetic substances Petroleum chemical products and by-products and all other products



- (6) To engage in the business of producing, buying, selling, exchanging, or doing any other acts of natural resources, energy nature and other energy, energy or fuel obtained from waste processing, both in raw material semi-finished products and finished products
- (7) To engage in the business of manufacturing, repairing, modifying, installing and trading machinery, engines, machine tools, machines Energy-saving, vehicles, power generators electrical appliance television receiver Pumps, machines, compressors, motors air conditioner heater chiller pollution eliminator, kitchenware, metal ware, sanitary ware, furniture, electrical equipment, plumbing equipment and other things related to water, including components, equipment, parts, materials and spare parts of the above products.
- (8) To engage in the business of manufacturing, repairing, modifying, installing and trading construction materials, equipment, tools and equipment for construction. All types of hand tools, paints, painting tools, glass, mirrors and all kinds of building decorations.
- (9) To engage in the business of manufacturing and trading plastics or other things which are similar both in the condition of raw materials semi-finished products and finished products.
- (10) To engage in the business of mining, rocks, gravel, sand, soil, ores crushing, ores dressing, mineral processing, smelting, ores of all kinds as well as industrial activities related to such things; purchase and distribution of minerals, stones, gravel, sand, soil and products from such industries, including other resources related to business operations within the scope of the objectives of the Company.
- (11) To engage in the business of manufacturing and trading of raw rubber, rubber sheets, latex or other types of rubber produced or derived from any part of the para rubber tree, including artificial rubber An imitation of such objects or goods by scientific methods.
- (12) To engage in the business of manufacturing and trading of medicinal and prophylactic drugs for humans and animals, artificial organs, medical equipment and chemicals. Medical, pharmaceutical and dental devices, technological products, fertilizers, pesticides and insecticides, and all kinds of plant and animal care products, scientific instruments.
- (13) To engage in the business of producing and trading agricultural products. Cultivation of all kinds of plants used as raw materials for pulp and paper production, including forestry, rubber plantation and other plantations Livestock business and finished and semi-finished products from it.



- (14) To engage in the business of manufacturing and trading of raw materials for pulp, paper pulp, paper, boxes, containers, and various products made from paper, stationery, textbooks, printed forms, books, school supplies, calculators, computers and other electronic devices, printers, dies, printing equipment, publications, newspapers, filing cabinets and all kinds of office equipment
- (15) To engage in the businesses of printing houses, books printing service, books and newspaper publishing and other publications.
- (16) To engage in the business of service stations and to provide the services of repairing, maintaining, inspecting, injecting, spraying anti-rust liquid for all kinds of vehicles, as well as installing, inspecting and fixing all kinds of loss prevention devices.
- To engage in the businesses of rice mills, saw mills, wood planning and drying factories, automobile body assembling factories, ceramics and porcelain factories, pottery factories, jute pressing factories, vegetable oil extraction factories, paper factories, spinning factories, textile factories, fabric dyeing and pattern printing factories, tyre manufacturing and retreading factories, iron factories, metal casting and lathing factories, galvanized iron factories, finished food factories, liquor factories, gas plant, cigarette factories, sugar factories, plasticware factories, metal rolling and melting factories, door and window factories, glass factories, beverage factories, rubber modling factories and automobile assembling factories, Petrochemical industry Radio and TV component and equipment factory and refractory brick factory, factory for sorting, eliminating, processing and treating general solid waste, hazardous waste industrial waste and other factories to benefit and or promote the objectives of the Company
- (18) To engage in the business of ports, navigation, transportation and transferring goods and passengers by land, sea, air, packaging of goods. Procurement of freight to shippers Deposit of goods imported or awaiting exportation, provision of services for importation or exportation of goods outside the Kingdom provide the service of customs clearance or other related businesses or being a part of the said business
- (19) To engage in the contracting business of constructing buildings, designing, consulting on construction and general construction materials. and constructing a building or anything, including accepting all kinds of civil work



- (20) To undertake the service business of guaranteeing debts, liabilities and performance of the contractual obligations of other persons, including guaranteeing the persons traveling into and out of the country under the law on Immigration and Taxation as well as other applicable laws, and giving suretyship of agreeing to be surety thereof.
- (21) To engage in the business of providing administrative services, training, research seminars, business management Providing consulting services in logistics, transportation, treasury, business, commerce, accounting, management services, marketing, economy, advertising and public relations, engineering, architecture, language, culture, law, science, agriculture, cooperatives, communications, telecommunications, energy, technology, Statistics Education Social Service industrialization information procurement (except securities trading)
- (22) To engage in the business of providing transportation and other technical advice, including law, accounting, engineering, architecture, agriculture, advertising and public relations businesses.
- (23) To engage in the business of undertaking to be a consultant and to give advice on problems related to management, commerce, and industry as well as problems related to production, marketing and distribution.
- (24) To engage in the service business of collecting, compiling, preparing, printing, and disseminating statistics and information on agriculture, industry, commerce, finance, marketing, as well as analyzing and evaluating business performance.
- (25) To engage in the businesses of private hospitals and health service facilities, including undertaking to treat patients and sick persons, as well as to perform technical practice and training on medical and health, to undertake for the objectives in this article not be contrary to the law on private higher education institutions or other laws.
- (26) To engage in the business of undertaking to be a manager and to protect interests, collect benefits and manage property of other persons.
- (27) To engage in the business of selling, buying, and exchanging foreign currencies upon permission from related agencies.



- (28) To engage in the bidding business for selling the products and working under a hire of work as specified in the objectives to persons, bodies of persons, juristic persons, government agencies and government organizations.
- (29) To act as a broker, an agent, and a commission agent in all types of undertakings and businesses, except in the insurance business, member recruitment for associations and securities trading.
- (30) To engage in the business of trading Importation into the country and exportation to foreign countries of goods related to construction, industry, commerce, agriculture or as defined in the objectives or in connection with the specified objectives.
- (31) To conduct a survey, research investigation, examining, isolating, or doing any other act; to obtain minerals, raw materials or data for use in the manufacture or sale of goods as specified in the objectives; or to obtain any material used in or in connection with business, construction and industry.
- (32) To obtain concession, concession certificate, patent, copyright, trademark, pattern, production process and any rights that are deemed beneficial to the business of the company; or other businesses that the company have a stake
- (33) To procure to acquire ownership, sell with right of redemption, exchange, lease, lease, hire-purchase, hire-purchase by leasing, mortgage, pledge, pledge or dispose of any property; as well as the interest of that property, including accepting mortgages without accepting deposits or receiving money from the public and taking advantage of that money or accept a pledge chattel for the business of the Company or other businesses in which the Company has an interest, except for the credit foncier business.
- (34) To borrow money or provide money by any means as the Board deems appropriate. except for the supply Capital under the law on finance business For the benefit of the company's business or other businesses that the company has an interest in including guaranteeing the borrowings of such companies or businesses by bringing the Company's assets to pledge, mortgage, or perform any act of guarantee for such debt
- (35) To make payment, order, issue, receive, transfer or endorse bills or other negotiable instruments relating to finance, including warranty card For the benefit of the company's business or other businesses in which the Company has an interest



- (36) To lending money providing commercial credit, certifying debt or giving credit by other means with or without collateral For the benefit of the company's business or other businesses that the company has an interest in whether direct or indirect benefit except in the banking business finance business and credit foncier businesses.
- (37) Take any action in relation to stocks and other negotiable instruments related to finance. for the benefit of business of the Company or other businesses in which the Company has an interest except for securities trading In the event that the company The issuance of debentures may be made only under the Securities and Exchange Act. or under other laws that have only been authorized
- (38) Participate in joint ventures with objectives matched with the Company or jointly invest with natural persons, juristic persons, or a group of persons to hold shares in a limited company Public Company Limited or become a partner Limited liability in a limited partnership whether a limited company Public Company Limited or that limited partnership whether there is an objective that is the same as the company or not
- (39) Invest, deal with money and company assets by any means which the Board of Directors of the Company deems appropriate, within the scope of the objectives of the Company.
- (40) To establish branch offices or appoint agents both inside and outside the country.
- (41) The company will issue shares at a higher price than their nominal value.
- (42) To engage in the warehousing business, silo business, or cold storage business upon operated only by having licenses from the Department of Internal Trade.
- (43) To engage in the business of production, purchase, sale, exchange, hire of or do by any other means of paper boxes, paper bags, paper containers or other products made of paper or pulp of any kind.
- (44) To engage in the business of contracting for commercial documents financial documents and other documents as hired including recording data, submitting documents, inspecting, and coordinating with various departments and other operations related to documents as hired
- (45) To engage in school Vocational schools, educational establishments, language schools, private colleges and universities and receive teaching, training and organizing academic seminars in all fields (upon permission from government agencies)



- (46) To act as an agent to be the operator of the activity instead to invest in school business vocational school Private colleges and universities both domestically and internationally (upon permission from government agencies).
- (47) To engage in the business of sending students for training, work visits, or further studies, both domestically and internationally.
- (48) To engage in the business of production, publishing and trading of books, textbooks, textbooks, publications, periodicals, and magazines in both Thai and English forms. and lessons are audio tapes, television tapes, video tapes) and computer lessons. and other characteristics such as transparent posters, slides, microfilms, audio records
- (49) To engage in the business of providing services, tools, measuring devices, all kinds of testing and testing equipment.
- (50) To engage in the business of purchasing, distributing, acting as a distributor, rent exchange import and export or doing otherwise by the telecommunication equipment radio transceiver communication tool as well as delivery tools Frequency spectrum used in all kinds of communication or related to telecommunications including equipment and spare parts of such products
- (51) To engage in the business of providing services for installation, maintenance, repair of telecommunications equipment. radio transceiver communication tool as well as devices for transmitting and transmitting spectrum used in all kinds of communication or related to telecommunications including equipment and spare parts of such products
- (52) To engage in the business of providing all types of telecommunication services, providing services in communication system equipment, tracking and navigation equipment.
- (53) To engage in in the business of purchasing business sell exchange as a distributor import and export or doing any other act in which the vehicle battery Car cameras, tires, parts, spare parts and accessories for cars as well as equipment related to all types of vehicles
- (54) To engage in the business of buying, selling, exchanging, being a distributor import and export or act in a manner other cars, pickup trucks, trucks, as well as all types of vehicles including parts Spare parts and accessories as well as equipment related to all types of vehicles



- (55) To engage in the business of trading Production and distribution, design, development and development of systems, programs, software, computers, websites or applications for operating systems on media such as computers, mobile phones. or any other electronic media devices of the same nature to sell or support the entire business and business of the company.
- (56) To engage in the business of providing the service of direct and indirect electronic commerce through a network using specific or generic programs which are not a business of direct sales according to the Direct Sales and Direct Marketing Act, B.E. 2545 (2002).
- (57) To engage in business as an online trading center for various types of goods by providing a central market area for trading or organizing auctions of various types of goods via the Internet and other related services
- (58) To engage in the business as an intermediary for payment of goods, service fees or any other fees including providing network services for payment by various methods
- (59) Providing delivery services of all kinds including products that have been ordered for service users and various services all related
- (60) To engage in the advertising business, advertising design, publication and brokerage services via the Internet, print and various media, including advertising space rental services. Internet publicity through publications and various media
- (61) To produce and distribute of various cards, including electronic cards to pay for goods, services or any other charges in advance or to purchase or services
- (62) To engage in the business of providing credit card network services, which means a network of services for sending electronic payment information from the cardholder's credit card to service users who issue such cards to approve the use of the card for each transaction or send and receive billing information arising from electronic payments as well as deduction between accounts
- (63) To engage in the business of Assemble an Electronic Data Capture Network (EDCNetwork), which is a network for sending electronic payment data from credit cards, debit cards, electronic money or any other electronic card to the centralized card issuing service provider or a connection point for data transmission between network users



- (64) To engage in the business of providing switch services in which payment (Transaction Switching) means a service as a center or a connection point for sending electronic payment transaction data to service providers as agreed.
- (65) To engage in the business of providing electronic money services (e-Money) used for purchasing goods. and/or receiving services This means the electronic card service issued by the service provider to the user. Named or not, with payment to the service provider in advance to be used to pay for goods, services or any other charges instead of paying with cash and the prepaid value or amount has been recorded.
- (66) To engage in the business of clearing services, which means a service of transferring, checking and confirming information in accordance with the payment order for calculating the balance of creditors. or the debtor of the service user to use such information to settle the balance between the creditor and debtor, including management for the settlement process to be completed.
- (67) To engage in the business of settlement services, which means payment system services agreed in advance between service users and service providers in order for service providers to adjust their creditor or debtor status of service users. The service provider will debit the account of the service user who is a debtor or accept debt payment by any other method as agreed and adjust the deposit account of the service user who is a creditor or pay by any other method in order for such debts to be extinguished
- (68) To engage in the business of providing electronic payment services through any device or through a network.
- (69) To engage in the business of providing services for accepting payments on behalf of creditors.
- (70) To engage in business information consulting services in various fields, including business planning, information system planning system design System implementation or education related to requirements in business information Using leading technologies in electronic information processing to the agency both public and private sectors
- (71) Providing storage services of all kinds.



- (72) To engage in the business of trading in vegetables, fruits, bamboo shoots, peppers, horticultural crops, cigarettes, tobacco, beverages, drinking water, mineral water, fruit juices, liquor, beer, fresh food, dried food, finished food, canned seafood canned goods, seasonings, seasonings, sauces, sugar, vegetable oils, animal feeds and other foodstuffs
- (73) To engage in the contracting business of transportation and transferring all kinds of concrete products, transportation of the dangerous goods and transportation of hazardous and non-hazardous industrial waste garbage, transportation the garbage and provide the general waste disposal services, transportation the garbage and provide the fuel waste processed from municipal waste services.
